DERIVATIVES

The Derivative Market registered increased activity closing the week with a total of 12 contracts worth Kes.923, 000 transacted against 6 contracts valued Kes. 164,000 posted last week.

EQUITIES

The Bourse closed the week with 82M shares valued at Kes.3.2Bn against 77M shares valued at Kes.2.5Bn transacted the previous week.

Turnover today rose significantly to Kes1.1Bn from the previous session's Kes.520M, the number of shares traded stood at 35M against 14M posted yesterday.

The market indicators ended the week with positive gains as follows;

The NSE 20 share index gained 3.81 points to close the week at 2618.62.

All Share Index (NASI) ended the week 1.36 points higher to settle at 157.93

The NSE 25 Share index was up 38.35 points to stand at 3918.48

Banking Sector

The Banking Sector had shares worth Kes.1.4Bn transacted which accounted for 43.74% of the week's traded value. Equity Group Holdings up 4.83% to close week at Kes.51.00 moved 17.9M shares valued at Kes.898M. KCB Group gained 1.94% to Kes.50.00 moved 5.7M shares valued at Kes.280M. I&M holdings traded 2.6M shares worth Kes.129M and closed at Kes. 48.95

Investment

The Investment Sector had shares worth Kes.332M transacted which accounted for 10.08% of the week's traded value. Centum actively moved 11M shares valued at 332M to close the week at Kes. 29.85

Manufacturing & Allied Sector

The Manufacturing & Allied Sector had shares valued Kes.622M transacted which represented 18.87% of the week's traded value. B.A.T closed the week 0.20% higher to Kes.491.00 moving 779,300 shares valued at Kes.374M. E.A Breweries moved 1.2M Shares valued at Kes.247M and closed at Kes.196.00

Telecommunication Sector

Safaricom gained by 2.81% to close at Kes.29.25 with shares worth Kes.834M transacted; this represented 25.30% of the week's traded value.
